4.1 Description of first aid measures

Brilliant Blue's production and use as a color additive in foods, drugs, cosmetics, and in laboratory fresheners or flushing water may result in its release to the environment through various waste streams. Its use in aquatic plant control will result in its direct release to the environment. If released to air, Brilliant Blue will exist solely in the particulate phase in the atmosphere since it is a salt and will be nonvolatile. Particulate-phase Brilliant Blue will be removed from the atmosphere by wet or dry deposition. Brilliant Blue contains chromophores that absorb at wavelengths >290 nm, and therefore may be susceptible to direct photolysis by sunlight; it has an absorption maximum of 630 nm. If released to soil, Brilliant Blue is expected to be mobile; this compound is expected to exist almost entirely in anion form in the environment and anions generally do not adsorb more strongly to soils containing organic carbon and clay than their neutral counterparts.
