12. ECOLOGICAL INFORMATION**12.1 Toxicity**

Resveratrol's production and use as a dietary supplement and anti-aging cosmetic ingredient may result in its release to the environment through various waste streams. It is a plant-specific enzyme that exists in 72 plant species, such as grapes, peanuts, berries and pine trees with grapes being the most abundant source. If released to air, an estimated vapor pressure of 1.2×10^{-9} mm Hg at 25 °C indicates resveratrol will exist in both the vapor and particulate phases in the atmosphere with the particulate phase being dominant. Vapor-phase resveratrol will be degraded in the atmosphere by reaction with photochemically-produced hydroxyl radicals; the half-life for this reaction in air is estimated to be 1.5 hours. Vapor-phase resveratrol is also degraded in the atmosphere by reaction with ozone; the half-life for this reaction in air is estimated to be 1.1 hours. Particulate-phase resveratrol will be removed from the atmosphere by wet and dry deposition. Resveratrol has UV absorption maxima at 307 and 321 nm and, therefore, may be susceptible to direct photolysis by sunlight. If released to soil, resveratrol is expected to have no mobility based upon an estimated Koc of 3.5×10^4 . Volatilization from moist soil surfaces is not expected to be an important fate process based upon an estimated Henry's Law constant of 1.4×10^{-16} atm-cu m/mole. Resveratrol is not expected to volatilize from dry soil surfaces based upon its vapor pressure. Biodegradation data were not available for soil.
