4. FIRST-AID MEASURES

4.1 Description of first aid measures

7. HANDLING AND STORAGE

7.1 Precautions for safe handling

Commercially available preparations of methylprednisolone should be stored at a temperature less than 40 °C, preferably between 15-30 °C; freezing of methylprednisolone acetate sterile suspension should be avoided.

Unreconstituted methylprednisolone sodium succinate sterile powder and reconstituted solutions of the drug, and methylprednisolone sodium acetate solution for injection should be stored at a controlled room temperature of 20-25 °C.

7.2 Conditions for safe storage, including any incompatibilities

Commercially available preparations of methylprednisolone should be stored at a temperature less than 40 °C, preferably between 15-30 °C; freezing of methylprednisolone acetate sterile suspension should be avoided.

Unreconstituted methylprednisolone sodium succinate sterile powder and reconstituted solutions of the drug, and

methylprednisolone sodium acetate solution for injection should be stored at a controlled room temperature of 20-25 °C.

12. ECOLOGICAL INFORMATION

12.1 Toxicity

Methylprednisolone's production and use as antiinflammatory glucocorticoid in human and veterinary medicine may result in its release to the environment through various waste streams. If released to air, an estimated vapor pressure of 3.9×10^{-14} mm Hg at 25 °C indicates methylprednisolone will exist solely in the particulate phase in the atmosphere. Particulate-phase methylprednisolone will be removed from the atmosphere by wet or dry deposition. Methylprednisolone absorbs UV light at a maximum of 243 nm and therefore is not expected to be susceptible to direct photolysis by sunlight. If released to soil, methylprednisolone is expected to have moderate mobility based upon an estimated Koc of 310. Volatilization from moist soil surfaces is not expected to be an important fate process based upon an estimated Henry's Law constant of 3.6×10^{-8} atm-cu m/mole. Biodegradation data for methylprednisolone were not available. If released into water, methylprednisolone is expected to adsorb to suspended solids and sediment based upon the estimated Koc. Volatilization from water surfaces is not expected to be an important fate process based upon this compound's estimated Henry's Law constant. An estimated BCF of 41 suggests the potential for bioconcentration in aquatic organisms is moderate. Hydrolysis is not expected to be an important environmental fate process since this compound lacks functional groups that hydrolyze under environmental conditions.
