4. FIRST-AID MEASURES

4.1 Description of first aid measures

Inhalation: Move to fresh air. Keep at rest in a position comfortable for breathing. Seek medical attention if symptoms persist.

Combustible. Heating may produce toxic fumes.

5.3 Advice for firefighters

Wear self-contained breathing apparatus (SCBA) and full protective clothing.

Fight fire from upwind. Cool containers with water spray until fire is extinguished.

6. ACCIDENTAL RELEASE MEASURES

6.1 Personal precautions, protective equipment and emergency procedures

Wear appropriate personal protective equipment (see Section 8).

Avoid breathing dust/vapor. Ensure adequate ventilation.

Evacuate personnel to safe areas. Keep people away from and upwind of spill.

6.2 Environmental precautions

Prevent product from entering drains, waterways, or soil.

Contain spill with inert absorbent material.

6.3 Methods and materials for containment and cleaning up

SRP: The most favorable course of action is to use an alternative chemical product with less inherent propensity for occupational harm/injury/toxicity or environmental contamination. Recycle any unused portion of the material for its approved use or return it to the manufacturer or supplier. Ultimate disposal of the chemical must consider: the material's impact on air quality; potential migration in soil or water; effects on animal and plant life; and conformance with environmental and public health regulations.

7. HANDLING AND STORAGE

7.1 Precautions for safe handling

Handle in accordance with good industrial hygiene and safety practices.

Wear appropriate PPE (see Section 8). Avoid contact with skin, eyes, and clothing.

Wash hands thoroughly after handling. Do not eat, drink, or smoke in work area.

Avoid dust formation. Use only in a chemical fume hood or well-ventilated area.

7.2 Conditions for safe storage, including any incompatibilities

Store in a cool, dry, well-ventilated area. Keep container tightly closed.

Store away from incompatible materials (see Section 10).

Protect from light and moisture.

Recommended storage (industry convention for research compounds): -20°C for long-term storage; 2-8°C for short-term use and transport.

12. ECOLOGICAL INFORMATION

12.1 Toxicity

Neotame's production and use as a non-nutritive sweetener may result in its release to the environment through various waste streams. If released to air, an estimated vapor pressure of 2.7×10^{-11} mm Hg at 25 °C indicates neotame will exist solely in the particulate phase in the atmosphere. Particulate-phase neotame will be removed from the atmosphere by wet or dry deposition. Neotame contains chromophores that absorb at wavelengths >290 nm, and therefore may be susceptible to direct photolysis by sunlight. If released to soil, neotame is expected to have moderate mobility based upon an estimated Koc of 390. The estimated pKa values are 4.11, 7.70, and 6.45, indicating that this compound will exist partially in the cation form in the environment and cations generally adsorb more strongly to soils containing organic carbon and clay than their neutral counterparts. Volatilization from moist soil surfaces is not expected to be an important fate process based upon an estimated Henry's Law constant of 2.3×10^{-17} atm-cu m/mole. Neotame may not volatilize from dry soil surfaces based upon its vapor pressure. Biodegradation data were not available. If released into water, neotame is expected to adsorb to suspended solids and sediment based upon the estimated Koc. Volatilization from water surfaces is not expected to be an important fate process based upon this compound's estimated Henry's Law constant. Base-catalyzed second-order hydrolysis half-lives of 5 years and 170 days at pH value
