Exposure routes:

Donepezil is well absorbed with a relative oral bioavailability of 100% and reaches peak plasma concentrations in 3 to 4 hours.

Signs and symptoms of exposure:

Symptoms of overdose include severe nausea, vomiting, salivation, sweating, bradycardia, hypotension, respiratory depression, collapse and convulsions. Increasing muscle weakness is a possibility and may result in death if respiratory muscles are involved.

12. ECOLOGICAL INFORMATION

12.1 Toxicity

Donepezil's production and use as a nootropic (memory or cognition enhancer) may result in its release to the environment through various waste streams. If released to air, an estimated vapor pressure of 6.8×10^{-10} mm Hg at 25 °C indicates donepezil will exist solely in the particulate phase in the atmosphere. Particulate-phase donepezil will be removed from the atmosphere by wet or dry deposition. Donepezil does not contain chromophores that absorb at wavelengths >290 nm and therefore is not expected to be susceptible to direct photolysis by sunlight. If released to soil, donepezil is expected to be immobile based upon an estimated K_{oc} of 4.0×10^4 . Volatilization from moist soil surfaces is not expected to be an important fate process based upon an estimated Henry's Law constant of 1.2×10^{-12} atm-cu m/mole. Biodegradation data were not available. If released into water, donepezil is expected to adsorb to suspended solids and sediment based upon the estimated K_{oc} . Volatilization from water surfaces is not expected to be an important fate process based upon this compound's estimated Henry's Law constant. An estimated BCF of 190 suggests the potential for bioconcentration in aquatic organisms is high, provided the compound is not metabolized by the organism. Hydrolysis is not expected to be an important environmental fate process since this compound lacks functional groups that hydrolyze under environmental conditions. Occupational exposure to donepezil may occur through inhalation.
