Commercially available montelukast sodium film-coated and chewable tablets and oral granules should be stored at 25 °C and protected from light and moisture with exposure for short periods to temperatures of 15-30 °C permitted. When stored as directed, montelukast sodium film-coated and chewable tablets have an expiration date of 2 years after the date of manufacture.

7.2 Conditions for safe storage, including any incompatibilities

Commercially available montelukast sodium film-coated and chewable tablets and oral granules should be stored at 25 °C and protected from light and moisture with exposure for short periods to temperatures of 15-30 °C permitted. When stored as directed, montelukast sodium film-coated and chewable tablets have an expiration date of 2 years after the date of manufacture.

12. ECOLOGICAL INFORMATION

12.1 Toxicity

Montelukast's production and use as an antiasthmatic may result in its release to the environment through various waste streams. If released to air, an estimated vapor pressure of 4.1×10^{-21} mm Hg at 25 °C indicates montelukast will exist solely in the particulate phase in the atmosphere. Particulate-phase montelukast will be removed from the atmosphere by wet or dry deposition. Montelukast contains chromophores that absorb at wavelengths >290 nm and therefore may be susceptible to direct photolysis by sunlight. If released to soil, montelukast is expected to have no mobility based upon an estimated Koc of 6.0×10^7 . The estimated pKa of montelukast is 4.3, indicating that this compound will primarily exist in the anion form in the environment and anions generally do not adsorb more strongly to soils containing organic carbon and clay than their neutral counterparts. Volatilization from moist soil surfaces is not expected to be an important fate process based upon the estimated pKa. Biodegradation data for montelukast were not available. If released into water, montelukast is expected to adsorb to suspended solids and sediment based upon its estimated Koc. An estimated pKa of 4.3 indicates montelukast will exist almost entirely in the anion form at pH values of 5 to 9 and therefore volatilization from water surfaces is not expected to be an important fate process. An estimated BCF of 3.2 suggests the potential for bioconcentration in aquatic organisms is low. Hydrolysis is not
