12. ECOLOGICAL INFORMATION

12.1 Toxicity

dl-alpha-Tocopherol's production and use as a biological antioxidant, as a nitrosamine blocker in meat curing, as an antioxidant in cosmetics, a dietary supplement, and chemical intermediate may result in its release to the environment through various waste streams. If released to air, an estimated vapor pressure of 1.4×10^{-8} mm Hg at 25 °C indicates dl-alpha-tocopherol will exist in both the vapor and particulate phases in the atmosphere. Vapor-phase dl-alpha-tocopherol E will be degraded in the atmosphere by reaction with photochemically-produced hydroxyl radicals; the half-life for this reaction in air is estimated to be 1.7 hours. Particulate-phase dl-alpha-tocopherol will be removed from the atmosphere by wet and dry deposition. dl-alpha-Tocopherol absorbs at wavelengths >290 nm and, therefore, may be susceptible to direct photolysis by sunlight. If released to soil, dl-alpha-tocopherol is expected to have no mobility based upon an estimated Koc of 2.5×10^7 . Volatilization from moist soil surfaces is expected to be an important fate process based upon an estimated Henry's Law constant of 7.9×10^{-5} atm-cu m/mole. However, adsorption to soil is expected to attenuate volatilization. dl-alpha-Tocopherol is not expected to volatilize from dry soil surfaces based upon its vapor pressure. Naturally occurring analogous alpha-tocopherol was biodegraded by aerobic bacterial communities isolated from marine sediment. However, biodegradation data on dl-alpha-tocopherol relevant to env
