4. FIRST AID MEASURES

4.1 Description of first aid measures

- **Ingestion:** If accidentally swallowed, rinse the mouth with plenty of water (only if the person is conscious) and obtain immediate medical attention. Do not induce vomiting.

5. FIRE FIGHTING MEASURES

7. HANDLING AND STORAGE

7.1 Precautions for safe handling

- **Safe handling:** Wear appropriate personal protective equipment. Use only under a chemical fume hood. Keep away from heat/sparks/open flame/hot surfaces. Take measures to prevent the build-up of electrostatic charge. Ensure adequate exhaust ventilation, especially if powder, aerosol or fumes will be generated. Avoid contact with skin, eyes and clothing.

- **Protections against explosions and fire:** Where possible, use anti-static and spark-proof equipment when handling.
